Topic: Spousal consent for refund of contributions

In line 7 of the title, after "3309.30," insert "3309.42," 1

Between lines 4661 and 4662, insert: 3

"Sec. 3309.42. (A) (1) Subject to section 3309.67 of the 4
Revised Code and except as provided in division (B) of this 5
section, a member who elects to become exempt from contribution to 6
the school employees retirement system pursuant to section 3309.23 7
of the Revised Code, or ceases to be an employee for any cause 8
other than death, retirement, receipt of a disability benefit, or 9
current employment in a position in which the member has elected 10
to participate in an alternative retirement plan pursuant to 11
section 3305.05 or 3305.051 of the Revised Code, shall be paid the 12
accumulated contributions standing to the credit of the member's 13
individual account in the employees' savings fund upon application 14
and subject to such rules as are established by the school 15
employees retirement board and provided three months have elapsed 16
since employment, other than employment exempt from contribution 17
under division (C) of section 3309.23 of the Revised Code, ceased. 18

(2) A member described in division (A) (1) of this section who 19

is married at the time of application for payment and ~~would be~~ is 20
 eligible for age and service retirement under section 3309.34, 21
 3309.36, or ~~3309.40~~ 3309.381 of the Revised Code or would be 22
eligible for age and service retirement under any of those 23
sections but for a forfeiture ordered under division (A) or (B) of 24
 section 2929.192 of the Revised Code shall submit with the 25
 application a written statement by the member's spouse attesting 26
 that the spouse consents to the payment of the member's 27
 accumulated contributions. Consent shall be valid only if it is 28
 signed and witnessed by an employee of the school employees 29
retirement system or a notary public. The board may waive the 30
 requirement of consent if the spouse is incapacitated or cannot be 31
 located, or for any other reason specified by the board. Consent 32
 or waiver is effective only with regard to the spouse who is the 33
 subject of the consent or waiver. 34

(B) This division applies to any member who is employed in a 35
 position in which the member has elected under section 3305.05 or 36
 3305.051 of the Revised Code to participate in an alternative 37
 retirement plan and due to the election ceases to be an employee 38
 for purposes of that position. 39

Subject to section 3309.67 of the Revised Code, the school 40
 employees retirement system shall do the following: 41

(1) On receipt of an election under section 3305.05 or 42
 3305.051 of the Revised Code, pay, in accordance with section 43
 3305.052 of the Revised Code, the amount described in that section 44
 to the appropriate provider; 45

(2) If a member has accumulated contributions, in addition to 46
 those subject to division (B)(1) of this section, standing to the 47
 credit of the member's individual account and is not otherwise in 48
 a position in which the member is considered an employee for the 49

purposes of that position, pay, to the provider the member 50
 selected pursuant to section 3305.05 or 3305.051 of the Revised 51
 Code, the accumulated contributions standing to the credit of the 52
 member's individual account in the employees' saving fund. The 53
 payment shall be made on the member's application. 54

(C) Payment of a member's accumulated contributions under 55
 this section cancels the member's total service credit in the 56
 school employees retirement system. A member whose accumulated 57
 contributions are paid to a provider pursuant to division (B) of 58
 this section is forever barred from claiming or purchasing service 59
 credit under the school employees retirement system for the period 60
 of employment attributable to those contributions." 61
