EACH EMPLOYER DESCRIBED IN DIVISION (D) OF SECTION 145.01 OF THE REVISED CODE, WHO SPONSORS A DISABILITY LEAVE PROGRAM IS REQUIRED TO MAKE THE PERIODIC EMPLOYER AND EMPLOYEE CONTRIBUTIONS, IN THE AMOUNTS SET PURSUANT TO SECTIONS 145.47 AND 145.48 OF THE REVISED CODE, FOR MEMBERS GRANTED DISABILITY LEAVE, BASED ON THE EMPLOYEES' RATE OF PAY IN EFFECT AT THE TIME DISABILITY LEAVE WAS GRANTED.
