Sec. 3307.38. Any member who has five years of service credit and has attained age sixty, or who has twenty-five years of service service credit and has attained age fifty-five, or who has thirty-two THIRTY years of service credit shall be granted service retirement after filing with the state teachers retirement board a completed application on a form approved by the board.

(A) Service retirement shall be effective on the first day of the month next following the last day for which compensation was paid if the board receives the application within three months after that date. If the application is received later than three months after that

date, the board shall place the member on retirement as of the first day of the month next following the date of receipt. LATER OF:

- (1) THE LAST DAY FOR WHICH COMPENSATION WAS PAID; OR
- (2) THE ATTAINMENT OF MINIMUM AGE OR SERVICE CREDIT ELIGIBILITY FOR BENEFITS PROVIDED UNDER THIS SECTION.

The service retirement benefit shall be the greater of the benefits provided in divisions (A) and (B) AND (C) of this section.

(A) (B) The annual single lifetime benefit of a member shall be the greater of the amounts determined by his total OHIO service credit multiplied by (a) eighty-six dollars, or by (b) two per cent of his final average salary, adjusted by the greater per cent shown in the following schedule opposite his attained age or Ohio service credit.

The annual single lifetime benefit payable under this division, shall not exceed ninety per cent of the final average salary.

- (B) (C) The annual single lifetime benefit of a member shall be the sum of the following amounts:
- (1) An annuity with a reserve equal to the member's accumulated contributions.
- (2) A pension equal to the amount in paragraph (1) above DIVISION (C) (1) OF THIS SECTION.
- (3) An additional pension of forty dollars annually multiplied by the number of years prior and military service credit, except years of credit purchased under section 3307.021 of the Revised Code.
- (4) An additional basic annual pension of one hundred eighty dollars, provided the member had ten or more years of Ohio service credit as of October 1, 1956, except that such additional basic annual pension shall not exceed the sum of the annual benefits provided by paragraphs DIVISIONS (C) (1), (2), and (3) of this division SECTION.
