AS USED IN THIS SECTION AND IN SECTIONS Sec. 742.03. (A) 742.04 AND 742.05 OF THE REVISED CODE:

(1) "POLICE OFFICER" MEANS A MEMBER OF THE FUND WHO IS AN EMPLOYEE OF A POLICE DEPARTMENT OF A MUNICIPAL CORPORATION.

(2) "FIREFIGHTER" MEANS A MEMBER OF THE FUND WHO IS AN EMPLOYEE OF A FIRE DEPARTMENT OF A MUNICIPAL CORPORATION OR A

TOWNSHIP.

(3) "FIREFIGHTER RETIRANT" MEANS A MEMBER OF THE FUND WHO IS RECEIVING AN AGE AND SERVICE OR DISABILITY BENEFIT AS A RESULT OF SERVICE IN A FIRE DEPARTMENT OF A MUNICIPAL CORPORATION OR TOWNSHIP OR A SURVIVING SPOUSE OF A DECEASED MEMBER WHO IS RECEIVING A BENEFIT AS A RESULT OF THE DECEASED MEMBER'S SERVICE IN A FIRE DEPARTMENT OF A MUNICIPAL CORPORATION OR TOWNSHIP.

"POLICE RETIRANT" MEANS A MEMBER OF THE FUND WHO IS RECEIVING AN AGE AND SERVICE OR DISABILITY BENEFIT AS A RESULT OF SERVICE IN A POLICE DEPARTMENT OF A MUNICIPAL CORPORATION OR A SURVIVING SPOUSE OF A DECEASED MEMBER WHO IS RECEIVING A BENEFIT AS A RESULT OF THE DECEASED MEMBER'S SERVICE IN A POLICE

DEPARTMENT OF A MUNICIPAL CORPORATION. (B) The administration, control, and management of the police and firemen's disability and pension fund, created under section 742.02 of the Revised Code, is vested in a board of trustees of the police and firemen's disability and pension fund, which shall consist of seven NINE members as follows: .

(A)(1) The attorney general; (B)(2) The auditor of state;

The fiscal officer of a municipal corporation who <del>(C)</del>(3) shall be appointed by the governor. This member's term shall be for three years, commencing on the fourth day of June and ending on the third day of June. The fiscal officer member shall hold office from the date of his appointment until the end of the term for which he was appointed. Any fiscal officer member appointed to fill a vacancy occurring prior to the expiration of the term

for which his predecessor was appointed shall hold office for the remainder of such term. Any fiscal officer member shall continue in office subsequent to the expiration date of his term until his successor takes office, or until a period of sixty days has

elapsed, whichever occurs first.

(D) Four (4) FIVE members known as employee members; two of whom shall be members of the fund who are employees of a police department of a municipal corporation, who shall be elected by ballot by the members of the fund who are employees of police departments of a municipal corporations and two of whom shall be members of the fund who are employees of a fire department of a municipal corporation or a township who shall be elected by ballot by the members of the fund who are employees of fire departments of municipal corporations or townships; except that the first members of the board representing employees of police departments small be appointed by the governor, within sixty days after November 5, 1965, for terms ending on the first Monday in June, 1967, and the first Monday in June, 1969, and the first members of the board representing employees of fire departments shall be appointed by the governor, within sixty days after November 5, 1965, for terms ending on the first Monday in June, 1968; and the first Monday in June, 1970.

At the expiration of the term of an employee member TWO EMPLOYEE MEMBERS SHALL BE POLICE OFFICERS ELECTED BY POLICE OFFICERS. TWO EMPLOYEE MEMBERS SHALL BE FIREFIGHTERS ELECTED BY FIREFIGHTERS. THE FIFTH EMPLOYEE MEMBER POSITION SHALL BE HELD IN ALTERNATING TERMS BY A POLICE OFFICER ELECTED BY POLICE OFFICERS AND BY A FIREFIGHTER ELECTED BY FIREFIGHTERS. MEMBERS of the board <del>appointed by the governor his successor</del> shall be elected for a term TERMS of four years as provided by section 742.04 of the Revised Code.

(5) ONE MEMBER KNOWN AS THE RETIRANT MEMBER WHO SHALL BE A RESIDENT OF THIS STATE. THE RETIRANT MEMBER POSITION SHALL BE HELD IN ALTERNATING TERMS BY A FIREFIGHTER RETIRANT ELECTED BY FIREFIGHTER RETIRANTS AND A POLICE RETIRANT ELECTED BY POLICE RETIRANTS. THE RETIRANT MEMBER OF THE BOARD SHALL BE ELECTED FOR A TERM OF FOUR YEARS AS PROVIDED BY SECTION 742.04 OF THE REVISED CODE.

NO EMPLOYEE MEMBER OF THE BOARD WHO RETIRES WHILE A MEMBER OF THE BOARD SHALL BE ELIGIBLE TO BECOME A RETIRANT MEMBER FOR THREE YEARS AFTER THE DATE OF THE MEMBER'S RETIREMENT.

SECTION 3. The first election for the fifth employee member of the Board of Trustees of the Police and Firemen's Disability and Pension Fund shall be for an employee member to represent firefighters and shall be held in May, 1983. Nominating petitions for the election shall be filed in the office of the Board not later than four p.m. on the first Monday in April, 1983, and ballots shall be mailed to members eligible to vote on or before the first Monday in May, 1983.

The first election for the retirant member of the Board shall be for a retirant member to represent police retirants and shall be held in May, 1983. Nominating petitions for the election shall be filed in the office of the Board not later than four p.m. on the first Monday in April, 1983, and ballots shall be mailed to persons eligible to vote on or before the first Monday in May, 1983.
