A member of the fund who is in the active service of the police or fire department of a municipal corporation, or in the active service of the fire department of a township, and is not receiving a pension or benefit payment from the police and firemen's disability and pension fund shall, in computing years of active service in such department under division (C) of section 742.37 of the Revised Code, be given full credit for service as a full-time policeman or fireman in a municipal corporation, or a full-time fireman in a township, provided that all of the following occur:

(A) Such service was rendered prior to January 1, 1967;
